As an exhibitor, I abide by and am subject to the following contracts and conditions for the Sucker Day Festival as follows:

**Booths:** Booths will consist of arts, crafts, food concession, commercial information and entertainment space.

**Display Area:** Booth space will be approximately 12'x12'. Exhibitors must supply their own table, chairs, panels, rain covers, generators, etc. Live animal operators must provide water, food, and all equipment.

**Guidelines:** Booth set-up is between 7:00AM and 9:00AM on Saturday, September 28, 2024. Operating hours are 9:00AM and no later than 2:00PM. However, if live entertainment will be provided into the evening hours, you will need to extend your booth time by contacting us. The Wetumka Sucker Day Committee will have final approval of all functions and services. Products such as obscene material **WILL NOT BE SOLD.**

**License and Taxes:** The craftsman or vendor is responsible for any required license or tax.

**Reservations:** The signed reservation application and contract must be received no later than Saturday, September 14, 2024.

12'x'12' booth spaces will be \$20.00. Food trucks will be \$35.00.

The Wetumka Sucker Day Committee reserves the right to amend the terms governing this agreement at any time prior to the celebration. The Sucker Day Committee reserves the right to limit and/or refuse booth space to anyone. The interpretation of all rules by the sponsor will be final. The Wetumka Sucker Day Committee and the citizens of Wetumka are excited! We want to extend a welcome to all for one of the best celebrations yet to come.
